

PARENTAL CONSENT, RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

IN CONSIDERATION of my minor child (the "Minor") being permitted to participate in the soccer tournament, friendly games, Soccer Camps, practices at **Paul Revere Middle School Fields, Bull Salas Park, Sports Creek Complex** or in any other activities sponsored by Club de Futbol America SA de CV / Nido Aguila Houston City SA or any of their event affiliates and/or sponsors in anyway ("Event"), the receipt and sufficiency of which are hereby acknowledged, I hereby acknowledge and agree to the following:

- 1. I ACKNOWLEDGE**, agree, and represent that I understand the nature of all activities and the Minor's experience and capabilities, and believe the Minor to be qualified, in good health, and in proper physical condition to participate in the Event. I further agree and warrant that if at any time I or the Minor believe conditions to be unsafe, I will instruct the Minor to immediately discontinue further participation in the Event.
- 2. I FULLY UNDERSTAND** and will instruct the Minor (a) that soccer involves vigorous physical activity, including running, jumping, rotation, violent body contact and rapid directional change (b) that the Minor will be engaged in activities that involve risk of serious injury, including permanent disability or death, and severe social and economic losses which might result not only from the Minor's own action, inaction, or negligence, but also the action, inaction, or the negligence of others, and/or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW, the rules of play or the conditions of the premises or of any equipment used. and (c) that there may be other unknown risks not reasonably foreseeable at this time (d) THE SOCIAL AND ECONOMIC LOSSES and/or damages that could result from those risks COULD BE SEVERE AND COULD PERMANENTLY CHANGE THE MINOR'S FUTURE.
- 3. I** consent to the Minor's participation in the Event and HEREBY ACCEPT AND ASSUME ALL SUCH RISKS, KNOWN AND UNKNOWN, AND ASSUME ALL RESPONSIBILITY FOR THE LOSSES, COSTS AND/OR DAMAGES FOLLOWING SUCH INJURY, DISABILITY, PARALYSIS OR DEATH, EVEN IF CAUSED, IN WHOLE OR IN PART, BY THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW.
- 4. I HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE**, **Paul Revere Middle School Fields, Bull Salas Park, Sports Creek Complex, Nido Aguila Houston City SA**, and, other participants, any sponsor, advertiser, promoter, and if applicable, owner and lessors of premises on which the activity takes place and each of their respective affiliates, administrators, owners, directors, agents, officers, members, volunteers, and employees (each considered one of the "RELEASEES" herein), FROM ALL LIABILITY TO ME, THE MINOR, my and the Minor's personal representatives, assigns, heirs, and next of kin, FOR ANY AND ALL claims, demands, causes of action, losses, obligations, or damages on my or the Minor's account caused or alleged to be caused in whole or in part by the negligence of the "Releasees" or otherwise, including the rescue operations and medical treatment and I further agree that if despite this release and waiver of liability, assumption of risk, indemnity agreement I, the Minor, or anyone on the Minor's behalf, makes a claim against any of the Releasees, I will indemnify, save, hold harmless each of the releases from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as a result of such claim, whether the claim is based on the negligence of the Releasees or otherwise.
- 5.** For purposes of this agreement, *participation in tournaments, friendly games, practices, soccer camps* and event activities. I also understand and agree that I and the Minor will behave in an appropriate manner and in accordance with all applicable rules for the tournament and while on the premises. I or the Minor will not engage in any behavior that reflects adversely against **Paul Revere Middle School Fields, Bull Salas Park, Sports Creek Complex, Nido Aguila Houston City SA**, their affiliated organizations, and/ or sponsors.
- 6. I HEREBY CONSENT** to have an athletic trainer, coach, doctor of medicine or dentistry, or associated personnel to provide me or the Minor with medical assistance and/or treatment, and I agree to be financially responsible for the cost of such assistance and/ or treatment if applicable.
- 7. I sign this agreement on my own behalf and on behalf of the Minor.**
I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS THAT I AND/OR THE MINOR WOULD OTHERWISE HAVE TO RECOVER DAMAGES FOR LOSSES OCCASIONED BY THE RELEASEE'S FAULT BY SIGNING IT AND HAVE SIGNED IT FREELY AND WITHOUT INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY THE LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD INVALID THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.

SOCIAL MEDIA RELEASE AND CONSENT FORM
